Motion and second to approve minutes were made by Alderpersons Wagner/Winkeler. Roll call vote: Alderpersons Frawley – absent, Winkeler - yes, Wagner – yes, Peck - yes, Poletti – yes. Motion carried.

Law Enforcement Committee

Alderperson Brenda Wagner, Acting Chairman

STATE OF THE DEPARTMENT REPORT

The Chief presented his written report to the elected officials for their review to which there were no questions or comments.

Alderperson Winkeler stated that he attended the Cardinal's baseball game and rode the MetroLink. He commented that a Fairview Heights police officer was at the station engaging with riders. Alderperson Peck stated that on Saturday night she went to the Cardinal's baseball game and at the MetroLink station there was a police officer in the parking lot, a sheriff's deputy

on one of the stands, and security on the MetroLink. She added that she never felt unsafe going to or coming back from the game.

CEO REPORT

Captain Beyersdorfer commented that the addition of Wade Gummersheimer has worked out well in Code Enforcement as there has been follow up with results in a timely fashion. He added that utilizing myGov helps enforcers stay organized.

Aldersperson Brumfield commented she is grateful about zoning and getting the City cleaned up.

Aldersperson King commented on the gift cards recently received by the Police Department to be distributed to those in need and believes this is a good idea. Captain Beyersdorfer stated he doesn't believe any have been handed out as of yet.

CODE ENFORCEMENT REPORT

There were no questions or comments regarding Code Enforcement Report.

MUTUAL AID SYSTEM - INTERGOVERNMENTAL AGREEMENT

Captain Beyersdorfer presented the resolution of membership in the Illinois Emergency Management Mutual Aid System. He stated the agreement has been brought forth every couple of years four approximately 16 years. Usually, it is around the time when the City is renewing their Emergency Operation Plan with the State of Illinois. This agreement is through the Illinois Emergency Management Association and has not changed in six years.

Aldersperson Peck requested that when this is presented in the City Council packet, the pages are number from 1 to 20. She also questioned if the agreement has had legal review to which Captain Beyersdorfer replied the current agreement has not, but it has been reviewed in the past. Aldersperson Peck stated that on page 17, Revocation of Prior Agreements, the effective date is shown as January 1, 2025 which needs to be changed.

Motion and second to forward a Resolution to City Council with recommendation of approval the Mutual Aid Intergovernmental Service Agreement by Alderspersons Winkeler/Poletti. Roll call vote showed Alderspersons Frawley - absent, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes. Motion carried.

RAFFLE ORDINANCE

The Mayor explained that the Raffle Ordinance is part of the City's Codes. The City has received a request to award a larger prize, a car, which value is higher than what is stated in the current Ordinance. He relayed that the current Ordinance states that the maximum prize is \$15,000 and requests the maximum prize be increased to \$100,000. The Mayor stated that the Ordinance needs to be updated and requests Council's support.

Aldersperson Peck stated that on the cover page of the Ordinance the Clerk is requesting that the heading include OF CHAPTER 8 (BUSINESS REGULATIONS – RAFFLES) ...

Public Works Committee

The Public Works Department received the annual bids on April 8 for materials used to maintain streets utilizing the Motor Fuel Tax Funds.

MFT MATERIAL BID – BITUMINOUS MATERIAL COLD PATCH

The Director stated that Asphalt Sales & Products was low bidder for cold patch at \$115 per ton and he is satisfied with their bid.

Motion and second to forward a Resolution to City Council with recommendation of approval the bid for Bituminous Cold Patch material of \$115.00 per ton by Asphalt Sales & Products by Alderpersons Wagner/Winkeler. Roll call vote showed Alderpersons Frawley - absent, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes. Motion carried.

MFT MATERIAL BID – CA-6 AGGREGATE

The Director stated this item is associated with rock. Columbia Quarry was low bidder with \$7.60 per ton which is within the industry standard.

Motion and second to forward a Resolution to City Council with recommendation of approval the bid for CA-6 Aggregate of \$7.60 per ton by Columbia Quarry by Alderpersons Winkeler/Wagner. Roll call vote showed Alderpersons Frawley - absent, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes. Motion carried.

MFT MATERIAL BID – PORTLAND CEMENT CONCRETE

The Director stated that Concrete Supply was low bidder with a price of \$150.00 per cubic yard.

Motion and second to forward a Resolution to City Council with recommendation of approval the bid for Portland Cement Concrete of \$150.00 per cubic yard by Concrete Supply of Illinois by Alderpersons Wagner/Winkeler. Roll call vote showed Alderpersons Frawley - absent, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes. Motion carried.

PEARSON DRIVE BID RESULTS/RECOMMENDATION

The Director of Public Works stated that at 3:00 p.m. today, five bids were received for the Pearson Drive project in Ward 2. The bids received were from just over \$600,000 to over \$1,000,000. Mayer Landscaping of Belleville was read as the apparent low bidder with a bid of \$611,930.06. The Director relayed that he is very satisfied with Mayer as they worked on the Market Place corridor and the Sites/Cory project. The Director stated \$700,000 is budgeted in the CIP Home Rule funds for construction, right-of-way acquisition and additional engineering. The Public Works Director recommends Mayer Landscaping for the Pearson Drive project.

Motion and second to forward a Resolution to City Council with recommendation of approval the construction contract with Mayer Landscaping for the amount of \$611,930.06 for the reconstruction of Pearson Drive by Alderpersons Wagner/Winkeler. Roll call vote showed

Alderspersons Frawley - absent, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes.
Motion carried.

DIRECTOR'S REPORT/PROJECT UPDATES

The Director presented his written report to the elected officials for their review to which there were no questions or comments.

The Director relayed that the Bunkum Road bridge project should be complete by the middle of next week.

The Director added that pavement marking should be complete on Lincoln Highway between Barnes & Noble and Joseph Drive.

Aldersperson Wagner questioned if the bike trail will be a separate bridge on Bunkum Road going over I-64 to which the Director replied that he has not seen the plans for this project.

The Director stated that the following projects are in the queue for this summer:

Old Collinsville Road from Lincoln Highway to Ashland, which should start in the next four to six weeks,

the turn lane from Old Collinsville Road to Ashland Avenue is on the current State letting,

the Longacre Drive project is also on the current State letting, and

the reconstruction of Pearson Drive.

Aldersperson Wagner requested that when these projects are ready, information is posted on social media. She added that when something is coming up or there is a business opening, Economic Development posts information on social media. She added even work on side streets could be posted as it shows residents that activity is happening in the City.

The City Clerk questioned if the Longacre Drive project will affect the Art Fair to which the Director replied that there is isolated patching which needs to be completed, but when the dates of the Fair are known, Public Works will work to make sure there is not a hindrance on attendance. The project is basically patching and then asphalt overlay. He stated it would probably take two to four days to lay the asphalt.

A motion and second was made to adjourn the Operations Meeting by Alderspersons Wagner/Poletti. All were in favor and the motion carried.

STATE OF THE DEPARTMENT

- After extensive testing, backgrounds and interviews, two traditional police officer candidates and one lateral candidate have been given conditional offers of employment. Once the two traditional hires pass additional testing, we hope to have them attend the May police academy.
- We are currently working with St. Clair County Emergency Management to transition away from Code Red to Everbridge for emergency notifications. We are now live with the new system.
- FHPD held its first Community Event of the year in the Stonewolf neighborhood. We had great attendance and excellent conversations with residents. Our next community event will be held on May 20th.
- Officer Jaylen Jernigan graduated from the 16-week police academy. He has started Field Training at FHPD.
- Officer Molly Muennich was awarded the 2026 Women in Criminal Justice Female Officer of the Year by ILETSB in East Peoria on April 8th. This is awarded to just one officer in the entire state of Illinois.

***A critical element of professional policing is ensuring the response to resistance we use is appropriate, legal, within policy, reviewed for improvement and enhanced training and supervised. Below is an abbreviated summary of the instances of our response to resistance to arrest:**

Officers stopped a Domestic Battery suspect and observed a handgun on the floorboard of the suspect vehicle. An officer drew his service pistol and ordered the male out of his vehicle. The male complied and was taken into custody without incident.

Officers located a suspect vehicle that had just been reported by a neighboring agency, having an occupant point a handgun at a passing motorist. Officers kept their handguns at a low-ready while conducting a high-risk vehicle stop. No weapon was ultimately recovered.

Officers responded to a Domestic Battery involving a highly intoxicated adult male. The male aggressively approached the first Officer on scene. The Officer extended his hand to keep the suspect back, and the suspect struck the Officer's hand. Officers engaged with the male and utilized a leg trip to take the suspect down, controlling his decent and then established a pinning position on the suspect, restricting the suspect's ability to resist. Utilizing a joint lock the officers were able to secure the male in handcuffs without causing injury to the suspect.

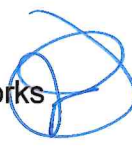

Resolution for Improvement Under the Illinois Highway Code – Old Collinsville Turn Lane at Ashland
(Agenda Item 1)

This Supplemental Resolution identifies our intent to use MFT funds of \$100,000.00 for our construction cost match for the Old Collinsville Road turn lane at Ashland Ave. The original Resolution was for \$150,000.00, however, there is a need for additional MFT funds as the construction cost estimate has increased.

With the Resolution approved, Motor Fuel Tax will fund The City's portion of engineering, right-of-way acquisition and construction costs which will be reimbursed to St. Clair County who is acting as lead agency for this project.

Resolution for Improvement Under the Illinois Highway Code – Ashland Ave. Phase 1
(Agenda Item 2)

This Resolution identifies our intent to use MFT for engineering costs that are to be reimbursed to St. Clair County for the design work associated with Ashland Avenue Phase 1. The City's portion of the preliminary engineering is approximately \$50,000.00 and appears in the Capital Improvements section of the current budget.

Vehicle Purchase – One ½-ton Truck – Morrow Brothers Ford, Inc.
(Agenda Item 3)

The Public Works Department, Vehicle Maintenance Division is interested in, and has budgeted for, the purchase of a new 1/2-ton truck with four doors. Fifty thousand dollars has been budgeted for this truck which will replace an older single cab truck which will continue to be used by the Street Crew. Morrow Brothers Ford, Inc., the State Bid dealer will be providing a quote for the vehicle.

Director's Report/Project Updates
(Agenda Item 4)

➤ ***Lincoln Highway Improvements***

This project is now complete as the raised reflective pavement markers were installed last week.

➤ ***Lincoln Trail Sidewalk Improvements***

The design work associated with the current phase of the proposed sidewalks, Union Hill to Bunkum, is on hold due to a policy issue with IDOT District 8. The Department is trying to work through this issue with the assistance of our consultant, Homer and Shifrin.

➤ ***Pearson Drive***

Currently, the contractor is in the process of executing the contract and contract bond for the project. As soon as the Department receives those items, a preconstruction meeting will be held with construction starting soon afterward.

➤ ***Elm, Oak, Cedar and Kadlec Drive***

There is nothing new to report on these projects at this time.

Engineering design work has started and continues at this time. Both projects have had the field survey work done and they are both making progress. Oak, Elm and Cedar design work is approximately 39% complete and Kadlec is approximately 45%.

➤ ***I-64 Ramp Overlay and 159 Bridge Work***

The tentative schedule for the I-64 ramp patch and overlay work is as follows:

The westbound ramps will be closed and worked on between May 26 and June 5.

The eastbound ramps will be closed and worked on between June 6 and June 14.

The contractor expects to begin work on the IL 159 structure in July with a tentative completion of September.

In addition, there is a separate contract to resurface IL 159 from north of I-64 to Lincoln Trail which will likely begin in September and be completed before shopping season in November.

If all goes as planned, they will have it looking good for the Holidays.

➤ ***Old Collinsville Road from Lincoln Hwy to Ashland***

This project has been awarded by the State with City concurrence to Keeley and Sons, for the sum of \$1,199,254.72 of which the City is forecasted to contribute \$600,000.00 from our Motor Fuel Tax funds. Construction will likely start in late May or early June.

➤ ***Longacre Drive from Rt 159 to Union Hill Road***

Bids for this project were opened at the State Letting in Springfield on April 24 with the Kilian Corporation read as low bidder with a proposal of \$1,289,612.47. This project will be funded entirely by State and Federal grants. Construction should start in late June or early July.

➤ ***Old Collinsville Road/Ashland Avenue Turn Lane***

Bids for this project were scheduled to be opened at the State Letting in Springfield on April 24 but no proposals were received for the project. The project will appear on the May 8 Bulletin and bids opened on June 12.

➤ ***Recent Grant Applications/Results***

During the last CMAQ/STP Grant cycle the City submitted applications for three potential projects. The results were as follows:

Ashland Avenue Phase 2, a project that is a joint effort between the City and St. Clair County was successful in its application for an STP grant.

Old Collinsville Road/Salem Roundabout, a project that is a joint effort between the City and the City of O'Fallon was successful in its application for a CMAQ grant.

Lincoln Highway Phase 2, a project that City applied for alone was not successful in its attempt to gain funding through an STP grant.
