Public Participation

A comment was voiced from a resident regarding the REC stating she has been against building the REC for two reasons: 1) it was an enormous expenditure, and 2) the citizens were not allowed to vote on it and believes they should have had the right to vote. The addition is another shock as more money is being spent. She then commented that it is one of the most beautiful facilities she has seen – gorgeous from the highway and from every view, it is spotless inside and families feel safe at the REC. However, she still opposes the REC and believes the money should have been spent on infrastructure. The resident stated that the REC is the Mayor's project, and that he guided the City through the COVID crisis. The resident is asking that the pavilion that is being constructed be named the Mark Kupsky pavilion in his honor. She believes the Mayor has done a good job in leading the City.

RESOLUTION FOR IMPROVEMENT UNDER THE ILLINOIS HIGHWAY CODE – OLD COLLINSVILLE TURN LANE AT ASHLAND

The Public Works Director presented a Resolution requesting to utilize \$100,000.00 from the Motor Fuel Tax Funds for the City's contribution to the Old Collinsville Road turn lane at Ashland Avenue project with St. Clair County.

Motion and second to forward a Resolution to City Council with recommendation of approval the Resolution for Improvement Under the Illinois Highway Code in the amount of \$100,000.00 for the Old Collinsville Road/Ashland Avenue Turn Lane project for construction costs by Alderspersons Wagner/Peck. Roll call vote showed Alderspersons Frawley - absent, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes. Motion carried.

RESOLUTION FOR IMPROVEMENT UNDER THE ILLINOIS HIGHWAY CODE – ASHLAND AVE. PHASE 1

The Public Works Director presented a Resolution requesting to utilize \$50,000.00 from the Motor Fuel Tax Funds to reimburse St. Clair County for preliminary engineering and design for the Ashland Avenue, Phase 1 project.

Motion and second to forward a Resolution to City Council with recommendation of approval the Resolution for Improvement Under the Illinois Highway Code in the amount of \$50,000.00 for the Ashland Avenue Phase 1 project from Old Collinsville Road to Joseph Drive for preliminary engineering costs by Alderspersons Wagner/Winkeler. Roll call vote showed Alderspersons Frawley - absent, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes. Motion carried.

VEHICLE PURCHASE – ONE 1/2 -TON TRUCK – MORROW BROTHERS FORD, INC.

The Director of Public Works stated that this vehicle purchase resides in the Capital Improvements Plan budget. The purchase is for a ½-ton truck, full size with four doors for the Vehicle Maintenance Division of Public Works. This vehicle will replace the 2011 truck which has over 100,000 miles and will be repurposed in Public Works for summer employees.

Motion and second to forward a Resolution to City Council with recommendation of approval the sales agreement with Morrow Brothers Ford, Inc. for a 2026 Ford ½-ton crew cab (4-door) pickup truck for the price of \$46,687.00 by Alderpersons Wagner/Winkeler. Roll call vote showed Alderpersons Frawley - absent, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes. Motion carried.

***A critical element of professional policing is ensuring the response to resistance we use is appropriate, legal, within policy, reviewed for improvement and enhanced training and supervised. Below is an abbreviated summary of the instances of our response to resistance to arrest:**

Officers conducted a pedestrian check on a male they suspected of being a felony fugitive. The suspect provided a false name and once it was confirmed that he was in fact the fugitive, he fled on foot. An Officer deployed his taser which struck the suspect, causing the suspect to fall to the ground. He was arrested without further incident.

Officers responded to a Domestic Battery where it was reported a male was armed with scissors. Officers encountered a highly agitated male who was armed with a handful of rocks. He ignored commands to drop them and then threw them at a window of a car in the driveway, causing the window to shatter. An officer pointed his taser at the male and ordered him to the ground. The male complied and was arrested without further incident. The male turned out to be a 16-year-old juvenile and was petitioned to the juvenile courts.

Officers conducted a pedestrian check. The suspect provided a false name and fled on foot. The Officer tackled the suspect and were able to arrest him without further incident. The male was charged with Obstructing a Peace Officer.

Officers responded to a report of a fight in progress in front of a house. They discovered a teenage female on top of another teenage female engaged in a fist-fight. The officers physically pulled the aggressor off of the other female and had to pick her up and set her on the ground to stop her aggression. The juvenile will be petitioned in juvenile court.

Officers responded to the FHPD lobby after learning that a wanted fugitive was attempting to conduct a tow release. The fugitive was told numerous times he was under arrest but refused to submit to handcuffing. As soon as he lunged for the door he was taken to the ground by the officer and secured in handcuffs. The officer suffered minor abrasions to his hand.

Surplus Vehicles – Motion to Auction
(Agenda Item 1)

The City currently has in its possession five vehicles, all of which are not worthy of adding to the City Hall staff fleet, that the Department is interested in retiring by auction. The vehicles are listed below:

The Department is requesting a motion to direct staff to retire the vehicles by advertising with Adam's Auction in Belleville. The vehicles will be taken to the Belleville facility where Adam's will advertise and auction. The entire proceeds will go to the City as the purchaser of the vehicle is responsible for the auction fees.

The Department is interested in continuing this approach as the staff time and advertising fees can be considerable. Four vehicles were auctioned late last year with Adam's and it worked well.

Director's Report/Project Updates
(Agenda Item 2)

➤ ***Lincoln Trail Sidewalk Improvements***

The design work associated with the current phase of the proposed sidewalks, Union Hill to Bunkum, is on hold due to a policy issue with IDOT District 8. The Department is trying to work through this issue with the assistance of our consultant, Horner and Shifrin.

➤ ***Pearson Drive***

The contract and performance bond have been executed and returned to this Department. We are currently working through a few utility conflicts but expect the start of construction to arrive in two weeks.

➤ ***Elm, Oak, Cedar and Kadlec Drive***

There is nothing new to report on these projects at this time.

Engineering design work has started and continues at this time. Both projects have had the field survey work done and they are both making progress. Oak, Elm and Cedar design work is approximately 45% complete and Kadlec is approximately 70%.

➤ ***I-64 Ramp Overlay and 159 Bridge Work***

The tentative schedule for the I-64 ramp patch and overlay work is as follows:

The west bound ramps are currently under construction.

The eastbound ramps will be closed and worked on between June 6 and June 14.

The contractor expects to begin work on the IL 159 structure in July with a tentative completion of September.

In addition, there is a separate contract to resurface IL 159 from north of I-64 to Lincoln Trail which will likely begin in September and be completed before shopping season in November.

If all goes as planned, they will have it looking good for the Holidays.

➤ ***Old Collinsville Road from Lincoln Hwy to Ashland***

This project has been awarded by the State, with City concurrence, to Keeley and Sons, for the sum of \$1,199,254.72 of which the City is forecasted to contribute \$600,000.00 from our Motor Fuel Tax funds. Construction will likely start on June 1 and is expected to take two to three months.

➤ ***Longacre Drive from Rt 159 to Union Hill Road***

Bids for this project were opened at the State Letting in Springfield on April 24 with the Kilian Corporation read as low bidder with a proposal of \$1,289,612.47. This project will be funded entirely by State and Federal grants. Construction should start in late June or early July.

➤ ***Old Collinsville Road/Ashland Avenue Turn Lane***

Bids for this project were scheduled to be opened at the State Letting in Springfield on April 24 but no proposals were received for the project. The project will appear on the May 8 Bulletin and bids opened on June 12.
