STATE OF THE DEPARTMENT

- Our department mourned the loss of a true PD supporter in Alderman Harry Zimmerman.
- Command staff met with the NAACP and O'Fallon PD, to continue creating unity with those partners.
- An off-duty officer, on his way home from his night shift, located a vehicle that had just been stolen from Moody Park. Two 14-year-old suspects were arrested.
- School is back in session and SROs Zywicki and Stitt are having a great time building relationships with our students, parents and faculty. It's the job of everyone to keep our children safe!
- An officer was nearly struck by a vehicle while assisting on a stop. He managed to jump out of the way, and later arrested the offending driver for DUI.
- Citizens Police Academy is scheduled to begin on September 3 and run through November 5th from 6p.m. – 9 p.m. each Wednesday evening.
- The Senior Police Academy is scheduled for October 9 – November 13th from 1 p.m. – 3:30 p.m. each Thursday afternoon. Share with your friends 55 years and older!
- Our department extensively assisted Swansea PD in locating a missing elderly man who walked away from his retirement home. The search ended in SUCCESS, with him being located a week later, alive!
- New carpet was installed in the Command wing of the PD. This is one of the last flooring projects we have, to replace all carpet original to the building. This was a budgeted project.

		Mom, dad, and a teenage girl live here most of the time, but now it is three 2 plus two preteen girls, a young boy, and another young girl. Sometimes, Mom's sister (I'm assuming) also stays with them. Throughout the year, they have also kept us awake long past quiet hours. We sat with the property manager in person and let her listen to a video of them shrieking past quiet hours, and she just looked at us and changed the subject. There are no consequences here. They also have completely taken over the common area outside their front door despite. They do not pay for this space, it is a lease violation, and management has already told them once to take their things back in. However, management also (apparently, based on email conversations) places the duty of alerting violations on other tenants despite the common area in question facing the intake road. It isn't a tenant's job to manage their property. Management can easily see their things every day when they drive in, but as I've learned, they do not care. These tenants have four patio chairs and two small, purple junk bins out there. They store cardboard and trash in these bins, and then they drink and smoke a foot away. They drop their butts wherever, and sometimes, that's in front of our front door where their other trash ends up. This is a fire and health hazard. I don't know that there's anything that can realistically be done about this, but there is also an excessively loud creaky area in the master bedroom in front of the doorway. It has gotten worse over the year. I believe it is from both structural damage (there is a crack running through my ceiling from mine subsidence) and an incorrectly installed ceiling fan. It would probably be a nonissue under normal circumstances, but these tenants pace or run all day and night. To say the quiet enjoyment of my living space is nonexistent is an understatement. I know this is very long, but I truly believe these tenants will receive a lease renewal offer the way things are run around here. I don't want the people who will move in after us to have to live the same year-long nightmare knowing management will not help them. Thank you for reading, and if nothing can be done, that's okay. ***A critical element of professional policing is ensuring the response to resistance we use is appropriate, legal, within policy, reviewed for improvement and enhanced training and supervised. Below is an abbreviated summary of the instances of our response to resistance to arrest:**

Officers responded to a local business following reports of a subject carrying a metal pole and attempting to strike other patrons. Upon arrival, officers quickly identified the individual and placed him in handcuffs to prevent further escalation. The subject was visibly agitated, yelling, and physically resisting efforts to conduct a search. In response, officers used controlled physical positioning by pinning him against a wall to limit his movement and ensure safety. When the subject attempted to spit at one of the officers, they brought him to the ground to maintain control. A search was conducted, revealing no contraband. The subject was then secured in a patrol vehicle and transported to the station. He was later charged with Aggravated Resisting, Aggravated Assault, and Disorderly Conduct. No injuries.

Officers identified a subject with an active felony warrant who was staying at a local hotel. Upon observing the subject exit the business and enter the parking lot, officers made contact and informed him he was under arrest based on the warrant. As officers attempted to take him into custody, the subject pulled away and fled on foot. Officers quickly pursued and brought him to the ground to prevent escape. Despite being on the ground, the subject resisted efforts to be handcuffed by refusing to place his hands behind his back. An assisting officer drew his department-issued Taser and issued a clear verbal warning regarding its potential use if the subject failed to comply. The subject then complied and was taken into custody without further incident. A subsequent search revealed the subject was in possession of a controlled substance. In addition to the outstanding warrant, he was charged with Resisting a Peace Officer and Possession of a Controlled Substance. No injuries.

Officers responded to a report of a domestic battery in progress at a local business. Upon arrival, they observed an individual matching the description of one of the involved parties approaching a vehicle and entering the front passenger seat. Due to the unknown nature of the subject's intentions—particularly the potential risk of retrieving a weapon—officers drew their department-issued Tasers and issued verbal commands for the subject to exit the vehicle. The subject complied without incident and was detained for further investigation. It was later

determined the individual was the victim of the domestic battery, and the offender had already fled the scene prior to officers’ arrival. No injuries.

A neighboring agency requested mutual aid assistance during a public community event in their city, citing the need for additional support with crowd control due to multiple physical altercations. Responding officers arrived and observed a large group of individuals actively engaged in a fight. In an effort to safely disperse the crowd and prevent further violence, officers deployed department-issued pepper ball launchers, aiming at the ground and nearby walls to create a deterrent without direct impact to individuals. The deployment was effective, and the group quickly dispersed on foot. No injuries were reported as a result of the incident.

STONEWOLF TRAIL PAVEMENT REMOVAL & REPLACEMENT BID RESULTS

The Director of Public Works stated that every year the Department spends a significant amount of time in Stonewolf Subdivision patching streets. Last Tuesday, the City accepted bids based on documents prepared in-house for approximately 3,000 square yards of concrete removal and replacement. The base bid was for Stonewolf Trail and the alternate bid was for Wolfrun Trail. The lowest total bid submitted was for approximately \$366,000 which was significantly lower than the Director estimated for both streets. Seven bids were received. The Director recommends proceeding with the low bid. The vast majority of the work will be done in September and October, with a December 15 completion date.

Motion and second to forward to City Council with the recommendation of approval the proposal from KRB Excavating, Inc., Trenton, Illinois for a total bid of \$366,650.25 for the Stonewolf Trail Pavement Removal & Replacement project by Alderspersons Wagner/Peck. Roll call vote showed Alderspersons Frawley – yes, Winkeler – yes, Wagner – yes, Peck – yes, Poletti – yes. Motion carried.

DIRECTOR'S REPORT/PROJECT UPDATES

The Director presented his written report to the elected officials for their review to which there were no questions or comments.

The Public Works Director commented that during the last week or two the street crew has been working in the northwest area of the Fox Creek Subdivision where water comes into the subdivision. Two hundred feet of creek has been realigned that is all downstream from the property that the City purchased to be used as a detention basin.

The Mayor asked that everyone keep the Public Works employees in mind who are working in the heat and that this is a very busy time of year for them. Minor work items will get pushed to the fall. Alderspersons Peck and Wagner commended the Director of Public Works. The Mayor thanked the Director for his dedication, the City Engineer and Administrative Assistant.

A motion was made by Alderspersons Wagner/Peck to adjourn the Operations Committee Meeting. All were in favor and the motion carried.

Director's Report/Project Updates
(Agenda Item 3)

➤ ***Lincoln Highway Improvements***

The Department has conducted a preconstruction meeting with Hank's Excavating & Landscaping to plan the proposed improvements associated with Lincoln Highway from Barnes & Noble to Joseph Drive. The intended start date is an approximately two weeks.

➤ ***Lincoln Trail Sidewalk Improvements***

The design work associated with the current phase of the proposed sidewalks, Union Hill to Bunkum, is on hold due to a policy issue with

IDOT District 8. The Department is trying to work through this issue with the assistance of our consultant, Homer and Shifrin.

➤ **Stites and Cory Drive**

Stites and Cory are currently under construction, with approximately 65% of the construction completed. Mayer has completed the curb and gutter installation on Stites and Cory and will now concentrate on driveway apron work.

➤ **Pearson Drive**

Millennia completed the survey for the additional drainage work at Walter Avenue and began analysis. They are about 60% complete with the Pearson roadway plans and fieldwork/lab testing has been completed for the retaining wall. Additionally, they are working internally on the stability models for the proposed retaining wall.

The Pearson Drive improvements are still on schedule for a January bid letting as discussed in prior meetings.

➤ **Stonewolf Concrete Removal and Replacement**

The work associated with this project is scheduled to start during the third week of September with an intended completion date of Veteran's Day.

➤ **FY 2026 Oil and Chip**
